The Board of Trustees of **Terrell County** ISD has called a Bond Election for two separate propositions.

Proposition A: \$5,400,000

Proposition B: \$590,000



PROPOSED PROJECTS:

PROPOSITION A:

- HVAC** replacement & air quality upgrades for the District's buildings.
- Upgrading the District's **transportation** by replacing vehicles based on need (to be accomplished in a rotation)
- Deferred **Maintenance** projects: plumbing maintenance, hot water heater upgrades, water run-off management, slab repair at HS field house, etc.
- Educational Equipment**: Purchase of vocational shop equipment and science lab equipment (including CTE course equipment as needed for the pathways of: nursing, digital design, education, business & welding)

Proposition B:

- Acquiring and updating instructional **technology** equipment needs for the district with a focus on the needs as they arise for the next 10 to 15 years.

Examples in order of priority:

Network Infrastructure - Switches, WiFi, Internet Security, Cameras

Classroom Presentation and interaction equipment and software

Staff and Student laptops and Chromebooks, Computer Lab computers

RECAPTURE.....what is it?



ACCORDING TO THE TEXAS EDUCATION AGENCY, TERRELL COUNTY IS CONSIDERED A **'PROPERTY WEALTHY'** SCHOOL DISTRICT.

THIS MEANS THAT **TCISD CURRENTLY GIVES AWAY OVER 13% OF THEIR MAINTENANCE AND OPERATIONS TAX COLLECTIONS** TO 'PROPERTY POOR' DISTRICTS. THIS IS KNOWN AS **RECAPTURE.**

How do we keep **OUR money** in Terrell County For **OUR students**?

Taxes that are levied for repayment of voted bonds
ARE NOT subject to recapture.

This means all local tax dollars raised for the
repayment of this bond issue will be kept locally for
OUR school.

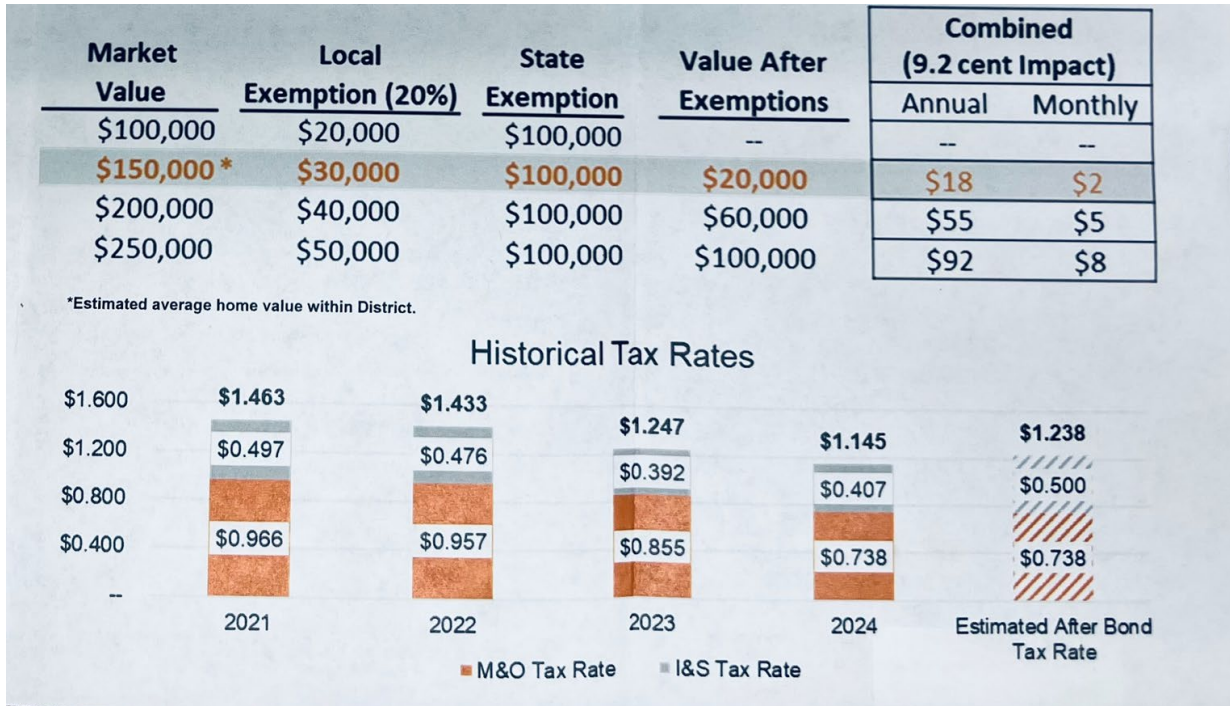

PLUMBING:

-8 SINKS THROUGHOUT THE NEED REPAIRED OR REPLACED

-4 URINALS ARE NOT FUNCTIONING

-5 TOILETS ARE NOT FUNCTIONING

-4 WATER FOUNTAINS ARE NOT WORKING

-THE BOILER IN THE GYM NEEDS REPLACED DUE TO AGE AND BUILD UP OF SEDIMENT

-CAFETERIA DISHWASHING STATION NEEDS REPLACED
