## **SCHOOL-PARENT COMPACT**

- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:

Annual parent-teacher conferences will be held before the end of the first grading period. The times for these meetings are staggered from 8:30 AM – 3:00 PM so that Parents can attend a time that fits their schedule.

Annual IEP meetings (if the student receives Special Education services)

3. **Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:

Report Cards every six-weeks

Progress Reports or Notices of Failure ever three weeks

4. **Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:

Each staff member will be available for parent conferencing at an average of 50 minutes per day. In addition, teacher emails and teacher phone numbers will be posted online for easy access.

5. **Provide parents opportunities to volunteer and participate in their child's class and to observe classroom activities,** as follows:

A variety of volunteer opportunities (different times of day, one-time event to ongoing opportunity, activities with their own student's class to school wide activity)
